6. Signature

Two signed originals of this Memorandum of Understanding will be produced, one to reside with each party

7. This MOU shall not create any legal obligation on either party and a separate agreement shall be entered into between the parties of this MOU in respect of execution of the work agreed under this MOU.
8. Service audit and program review functions shall be performed jointly when appropriate. Both parties mutually agree not to use the name of the other party in any public information without permission of the concerned party.
9. The above **MoU** is valid for **five years** from the date of signing




